2026-2027 Music School Tuition Agreement

The Music Tuition Agreement (“Agreement”) is entered into between Patricia F Robinson Music Studio and the undersigned student and/or parent legal guardian.

By acknowledging this Agreement, the Student/Parent/Guardian acknowledges that they have read, understand and agree to abide by all policies and procedures outlined below.

1. Term of Agreement

This Agreement is a binding one – year commitment for the fall of 2026- fall of 2027 Music School Year, including:

- Fall 2026
- Winter 2026
- Spring 2027
- Summer 2027

Enrollment reserves the student’s lesson time for the entire school year.

2. Lesson Schedule

- Standard lessons are 30 minutes once per week, unless otherwise agreed upon by the Studio
- Lessons are reserved exclusively for each student.

3. Registration Fee

A non-refundable annual registration fee of \$200.00 per family is due upon enrollment to reserve the students' place in the Studio.

4. Tuition

The Students/Parents/Guardian agrees to pay the following tuition rates:

- Children (ages 4 years and under): \$50 per weekly lesson
- Children (5-17): \$55 per weekly lesson
- Adults: \$60 per weekly lesson
- Trial Lessons: \$65

ALL LESSONS ARE PAYABLE ON THE 1ST OF THE MONTH FOR THE ENTIRE MONTH

Family Discount

Families enrolling more than one child will receive a \$5 discount per additional child

Prepaid Tuition Discounts

Families choosing to pre-pay tuition may receive the following discounts:

- Pay 12 months in advance: 20% discount
- Pay 6 months in advance: 15% discount

5. Monthly Payments

- Tuition is due monthly in full the 1st of the month for the entire month
- Tuition payments will be automatically processed through Session Up on the 1st day of each month using the payment method on file
- The Student/Parent/Guardian is responsible for ensuring that payment information remains current

6. Attendance and Make-Up Lessons

Regular attendance is expected

- Tuition is based on enrollment, not attendance
- Missed lessons remain the responsibility of the Student/Parent/Guardian and must be paid for.

- Students may reschedule missed lessons through SessionUP app to teacher availability and Studio policy

7. Late Payments

Failure to make timely payments will be charged a \$10.00 fee and may be subjected to:

- Late payment notices
- Suspension of lessons
- Loss of students' reserved lesson time
- Dismissal from the Studio

8. Lateness

Students are expected to arrive on time

Late arrivals will result in a shortened lesson, as lessons will end at the schedule time to avoid disrupting subsequent students.

Repeated lateness or failure to meet financial obligations may result in dismissal from the Studio.

9. Studio Contact

All students, parents, family members and guests are expected to conduct themselves in a respectful, courteous, and orderly manner while on Studio property or participating in Studio events.

Disruptive, disrespectful or inappropriate behavior may result in dismissal from the Studio.

10. Release of Liability

Patricia F Robinson Music Studio, its teachers, staff and representatives shall not be held responsible for any accidents, injuries, loss of personal property or damage that may occur while on Studio premises or participating in Studio activities.

By signing this Agreement, the student/parent/guardian voluntarily assumes all risk associated with participation in music lessons and Studio events.
